## Accident report

The only report of this accident that has been made available to date was in a UNMACCA spreadsheet covering Mine accidents in 2008 and 2009. The conversion of the data into a DDAS file shows how spreadsheets summarise to the exclusion of including essential information. Text in square brackets [ ] is editorial. This record will be revised as more information becomes available.

The summary is reproduced below, edited for anonymity.

Incident occurred: 1<sup>st</sup> August 2008, 06:00

Injured: 1 injured, [Name removed]

He has lost his right leg below knee joint and got some minor injuries on face and right hand as well

Crossing the land suddenly stepped on an AP mine and the accident happened

AP blast mine

Task: AF/0101/00083/MF0824, Tapa-i-Salam village, Ward # 03, Kabul Province, Central Region

It is the conclusion of the investigation team that the mine was not missed from the clearance team but had been brought by someone and put there. One of the local residents named [Name removed] narrated that, he had placed a mine under a small stone, but has not been found there. The crater made by exploded mine was less than 5cm which shows that as it was put on the ground [surface].

#### Analysis

The primary and secondary causes of this accident are listed as *Other* because there is not enough information to judge whether the mine was really missed or placed after the clearance was completed. If the mine was really on the ground surface and left no real crater, this supports the contention that the mine was placed after the clearance was completed. The early hour of the accident may explain why the Victim did not see it.

The "Inadequate investigation" listed under notes refers to the absence of a full accident report.
